R. Grinberg Test for Spirituality and Humanism

Modernity offers Europe and the rest of the world a unique test of spirituality and humanism. It's about who and how to respond to the flow of refugees to Europe from North Africa and the Middle East.

S. Glinkina, N. Kulikova On the Issue about the Effectiveness of the Transformation of the Social System in the Countries of Central and Eastern Europe

The revolutions in Central and Eastern Europe at the turn of the 80/90-ies became the biggest political event of the second half of the XX century. They marked the collapse of the world socialist system, in which frameworks the CEE countries had developed almost half a century after the Second World War and laid the foundation for the transformation of their social system.

Has the Transformation Really Ended?

In connection with the 25th anniversary of the «velvet revolutions» in the former socialist countries, the journal asked the public figures and scientists of Hungary, Poland, and Slovakia, to answer a number of questions.

I. Angelov Bulgaria: Transition to Democracy or the Restoration of the Primitive Balkan Capitalism

It took a quarter of a century since the beginning of the processes of transformation and European integration of Bulgaria. During this period the republic made the transition from a planned to a market economy, it became a fully fledged member of the EU and NATO. But how effective the constructed economic model of the country proved to be, and did its competitiveness increase? The analysis of the socio-economic indicators of Bulgaria and its place in the international division of labor leads to disappointing conclusions.

A. Inotai. Looking Behind the Curtain: What about the Hungarian "Economic Miracle"?

In the last period, the Hungarian, and partly also the international mass media are full of positive economic developments in Hungary. However, the influential international organizations so far are not seeking to raise the ratings of Hungary
